Notice is hereby given that the Vanderburgh County Council will hold hearings and take action upon Ordinance No. CO. 11-14-005, entitled Ordinance Amending the Ordinance of the Vanderburgh County Council for the Imposition of an Excise Surtax and Wheel Tax in Vanderburgh County, at a special meeting on Wednesday, November 26, 2014 at 8:45 a.m. and at its regularly scheduled meeting on December 3, 2014 at 8:30 a.m. The meetings will be held in Room 301 of the Civic Center Complex, 1 N.W. ORDINANCE AMENDING THE ORDINANCE OF THE VANDERBURGH COUNTY COUNCIL FOR THE IMPOSITION OF AN EXCISE SURTAX AND WHEEL TAX IN

VANDERBURGH COUNTY

ORDINANCE NO. CO. 11-14-005

WHEREAS, on or about April 5, 1989, the Vanderburgh County Council passed Ordinance No. 89-06290 entitled Ordinance of the Vanderburgh County Council for the Imposition of an Excise Surtax and Wheel Tax in Vanderburgh County, which is Chapter 3.10 Excise Surtax and Wheel Tax of the Code of Ordinances of Vanderburgh County, and said Ordinance was effective January 1, 1990;

WHEREAS, the General Assembly of the State of Indiana enacted I.C. 6-3.5-4-2 version b, sec. 2, which amends the Indiana Code to add “motor driven vehicles” to the list of vehicles that the license excise surtax applies; and

WHEREAS, the Vanderburgh County Council desires to amend Section 3.10.010 of the Code of Ordinances of Vanderburgh County to add motor driven vehicles as amended by the Indiana Code.

NOW, THEREFORE, BE IT ORDAINED by the County Council of Vanderburgh County, Indiana, as follows:

Section 1. Amendment of Section 3.10.010 Annual License Surtax.

Section 3.10.010 of the Code of Ordinances of Vanderburgh County is hereby amended to add subsection D by inserting the words “D. Motor Driven Vehicles.” Section 3.10.010 shall now read as follows:

Commencing on and after January 1, 1990, there is hereby imposed upon each of the following motor vehicles registered in Vanderburgh County, an annual license excise surtax of two percent (2%):

- A. Passenger vehicles.
- B. Motorcycles.
- C. Trucks with a declared gross weight that does not exceed eleven thousand (11,000) pounds gross vehicle weight.
- D. Motor driven vehicles.

In no event shall the net annual license excise surtax be less than the sum of Seven Dollars and Fifty Cents (\$7.50) per vehicle.

Section 2. Effective Date.

This Ordinance shall be in full force and effect from and after its passage by the Vanderburgh County Council and following publication.
